Messages and Consequences of Recent Trends in University Lifelong Learning Across Europe to Policy Makers

eucen is turning the focus of its Policy Talks 2021 to impacts of trends in university lifelong learning having been identified by some recent surveys by international organisations to promote lifelong learning through higher education institutions, like UIL, IAU and EUA.

Major trends in university lifelong learning indicate a shift in quality concerns, methodologies used, structural changes in skills and competence development referring to micro credentials and other new formulas, together with collaborative formations of knowledge transfer in association with workplaces and other significant community-based activities of engaged lifelong learners through particular models of learning cities and regions.

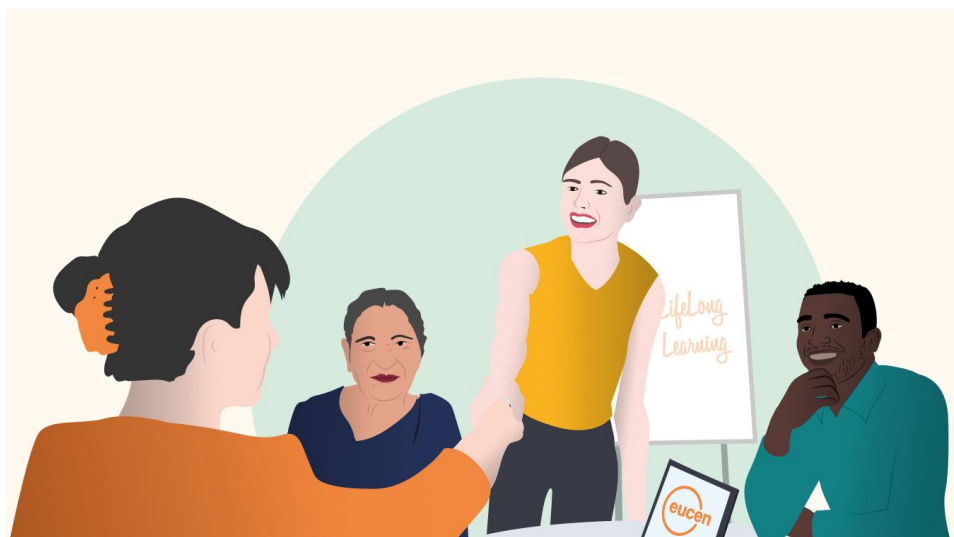
